- June 2025: PSAC in person meeting Seattle / Bellevue
- Ongoing:
  - Investment discussions related to coverage enhancement and network evolution (e.g., PTT, location-based services)
  - Advocacy in support of FirstNet's mission
  - Collaboration opportunities with FirstNet Authority Board within the respective associations and / or jurisdictions served
  - Tribal Advisory Group development of briefing materials geared towards tribal councils

### FY2025 Quarter 1 Public Safety Engagement Accomplishments

















- Attended major law enforcement association conferences, including MCSA, NSA, and MCCA, and 35th annual Congressional Fire Services Institute (CFSI) symposium
- Engaged with national, state, and local stakeholders on key broadband technology topics (e.g., push-to-talk, border coverage needs)



- Provided virtual and on-site planning and support to local, state, and federal public safety stakeholders for various planned events (e.g., New Year's Eve, Inauguration, Super Bowl LIX, Groundhog Day)
- Coordinated with AT&T in support of events nationwide
- Examined network performance during various incidents

#### Coverage Enhancement Workshops

- Launched pilot coverage enhancement workshops and successfully conducted five pilots between November and March
- Gathered specific feedback regarding state and local coverage needs
- Captured lessons learned to improve workshop delivery and underlying model



### **FirstNet Differentiators**



Operates over dedicated spectrum for public safety



Uses a separate core built for public safety communications traffic and security



Is built on network plans approved by every state and territory



Is built on global standards developed with public safety representation



Ensures always-on priority and preemption of voice and data for public safety users



Ensures accountability for public safety through the FirstNet Authority



Provides public safety with on-demand mobile coverage assets and support at no additional cost



Gives local control and access to network status to public safety agencies



Engages with public safety to guide network investment, expansion, and innovation
